Motion to approve Water Master Report by Director Weber, seconded by Director McDowell, five ayes, 0 nays, 0 abstentions

General Manager report

We have gotten approved to use water, from the state, after filing petition. Cal trans will try to keep job under 100k for highway project. Dan Bush is hired as project manager.

Collections policy Pat wrote and distributed to Board.

Financials: it looks like we're over budget, but it's because of accounting of the customers who paid annually.

New Business: Declaration of surplus land, funding for highway 175 project: Discussed and then a Motion was made by Director Duke to authorize the G.M. in consultation with the Chair to liquidate it. G.M. will list it on a government surplus website, and talk to a realtor to determine a minimum bid amount. Director McDowell seconded, 5 ayes, 0 nayes, 0 abstentions.

Motion by Director Weber to contact Moke Simon with mandatory need for money for highway 175 project. Director McDowell 2nd, 5 ayes, 0 nayes, 0 abstentions. Chair to write a letter to Moke.

We received donation from Cal Pine for \$6000 to pay part of yearly water tank payment. Director Ohsiek made a motion that we express our appreciation for their generous donation. Director Duke seconded, 5 ayes, 0 nayes, 0 abstentions.

Possible annexation of additional customers along 175

Motion by Director Weber: The board adopts a policy for annexation of new customers without hookups: For anyone who is not already in our system, they must pay all infrastructure costs to join our system, including engineering and permits to join our system. Plus the \$7500 expansion fee to ASCSD. Seconded by Director McDowell, 5ayes, 0 nayes, 0 abstentions.
